Vendor Information

The Back of the Yards Neighborhood Council is pleased to announce its **28th Annual Fiesta Back of the Yards** on **June 8, 9, & 10, 2018**. We anticipate approximately 300,000 attendees over the three-day weekend. The event will be held along 47th Street between Damen and Ashland Avenue. The hours of the festival are Friday from 5:00 – 10:00 p.m., Saturday and Sunday from 12:00 p.m. – 10:00 p.m. We encourage all interested applicants to contact the BYNC as soon as possible in order to reserve your booth space, for spaces run out on a first-come first-serve basis.

The following prices are for a booth space ONLY. (Note: These prices do not include tent). Prices include \$25.00 fee for Merchandise vendors and \$75.00 fee for Food vendors on a Temporary Vendor License required by the City of Chicago.

- ✚ Merchandise Booth.....\$600.00 each. Includes permit, electricity, and 10'x10' space.
- ✚ Food Booth.....\$1,500.00 each. Includes permit, electricity, 10'x20' space, and portable hand wash station.
- ✚ Informational Booth.....\$500.00 each. Includes electricity and 10'x10' space.
- ✚ Non-for-Profit Organization.....\$300.00 each. Includes electricity and 10'x10' space. Must submit copy of 501c3 Organization- tax exempt status.

Additional spaces are an option only if there is space available next to current booth and we are limiting spaces to only ONE per vendor.

TENT RENTAL – Every vendor will have the opportunity to rent a tent through the organization, however, deadline to order a tent for your space will be Friday, May 25th, after that, you will be unable to order one.

Prices for tent rental are the following:

10'x10' Tent Rental w/counter & skirt\$250.00 each

10'x20' Tent Rental w/counter & skirt..... \$400.00 each

Note: If for any reason you decide to cancel, deposits are **NOT** refundable.

\$200 minimal deposit is required and complete application to reserve your booth.

Final payment must be due in cash, credit card or money order by May 25th.

No personal checks accepted after May 1st.
